## OLD IOTA 01 | NEW IOTA 01 | 18:19 Uhr | Reports

#### Marcus reports from the Executive Board

- Paul Weiß resigned on 04.09.2025 from his position as member of the executive board and member of the StuCo for personal reasons, as collaboration was unfortunately no longer possible.
- Today, 5 amendments to the rules were announced. These concern updates to references.
- Recently, a warning system for finances was introduced. If student department councils (FSRe) commit serious mistakes or engage in illegal activities, this will have concrete consequences in the future.
  - On the first violation, there will be a warning and a clarifying meeting between the FSR,
     StuCo finances, and the StuCo executive board.
  - On the second violation, the FSR's finances will be frozen for one month.
  - On the third violation, the freeze will remain in effect until the end of the semester.

Warnings and freezes always only apply to the current semester. Freezes must be approved by the StuCo. The system was jointly developed by the Executive Board and Finances and is based on § 37 (2) of the Financial Regulations (FinO).

- Yesterday the **fzs** finally confirmed that since August 21st we are once again a supporting member and thus can save on GEMA fees again.
- Today the StuCo received an **invitation to the award ceremony** of the Charlotte-Figulla Prize 2025 and the 24th Jena Prize for Civil Courage on 26.09.2025 at 5 pm in the Historic Town Hall of Jena. If you are interested, feel free to attend.
- Our ballot box (Wa(h)l-Urne) finally has whales again!

### Klara reports from the Market of Opportunities

- The organization of the **MdM** is still ongoing.
- More than 90 booths were registered until now.
- However, we are unsure about **3 booths**, whether to allow them: the Chinese Christian Fellowship, the Revolutionary Communist Party, and Viva con Agua. What does the committee think about these booths?
- The committee supports Viva con Agua and rejects the Chinese Christian Fellowship and the Revolutionary Communist Party.
- Klara will inform the respective groups of the result.

#### Anne reports from the Election Board

- The Constituent Meeting for the StuCo of the new term will take place on Sunday, 05.10.2025 at 3 pm in SR 113.
- Another **resignation** from the new committee has been recorded.
- The Election Board has created a "**How to Konsti**" for the student department councils (FSRe) and sent it to all of them.

#### Anne reports from the Department of Internal Affairs

• The Department of Internal Affairs has by now received (almost) all **student department statutes**. These are now being reviewed one by one, after which the respective FSRs will be contacted.

#### Peter reports from the Public Relations Department

• On November 28, this year's **Reception for honorary posts** will take place.

#### Willi reports from Finances

• There will be **new forms and templates** for releases of funds, finance applications, finance plans, and financial outcome overviews. The background is to resolve issues from day-to-day operations that slow down the process of applying for and reimbursement of funds. The biggest change will be the combination of the currently three one-page forms (FSRe, departments, and FSR-Kom/StuRa) into a two-page general form, which includes necessary additions compared to its predecessors and thereby also reduces the workload of the financial plan template.

The event emerged from our partially self-organized reading group in the Master's program in Social Theory. In the course of our intensive engagement with Herbert Marcuse's "One-Dimensional Man" (1964), we found that the work offers surprisingly many points of connection to current debates in social theory. Marcuse's analysis of the "one-dimensional society", his critique of advanced industrial society, the associated technocratic domination, as well as his reflections on possibilities of liberation, seem to us highly relevant even today. Out of the desire not only to discuss these insights in a small circle but also to make them accessible to a broader audience, the idea for a public event was born.

#### **Motion Text**

Dear all,

In January, the EUSA in Karate took place. This concerns the subsequent approval of registration fees. The registration fees amount to 300€.

#### Discussion

- Marcus presents the motion.
- Anne asks why we are once again deciding retroactively on an release of funds for the Sports
  Department.
- Willi explains that the athletes approached the Head of our Sports Department too late and that it is not his fault.
- Anne sees a problem in the fact that the delay concerns half a year and points out that this may not be compatible with the FinO. She also mentions that a few months ago it was discussed that the Sports Department was broke.
- Willi explains that the decision could only be covered by the supplementary budget.
- Klara asks whether we should really be planning with money that has not yet been approved.
- Levke explains that she believes she already knows the athlete from a previous release of funds. He should therefore be aware of the deadlines.
- **Anne** explains that §35 (2) of the FinO states that corresponding missing decisions must be "made up for immediately in the case of objective justification". For her, half a year no longer falls within this framework.
- Levke feels that 300 € in registration fees for one person is also comparatively very high.
- Ernst suggests that we could only pay it in portions.
- Several people reject this option.

#### **Motion Text**

In May, the adh championships in volleyball took place. This concerns the subsequent approval of registration fees. The registration fees amount to  $150 \, \text{\ensuremath{\in}}$ .

#### Discussion

- Marcus presents the motion.
- Willi wonders why the registration fees differ so much in amount from the EUSA.
- Levke explains that this is often due to the type of organization.
- Anne sees the same problems as in the previous funding release.
- Ernst asks whether this is a similar situation to the previous IOTA.
- Marcus explains that this is also a retroactive decision. However, the championships did not take place as long ago as in the previous IOTA. Another problem is that the invoice was not issued to the student body, but to Department 2 of the university.
- Sander explains that he sees a difference between 150 € for 6 people and 300 € for one individual, and therefore considers the funds more justified.
- **Anne** explains that the sports science students (SpoWis) in general should be more aware of the deadlines.
- Levke asks whether we should vote on this if Department 2 received the invoice.
- **Anne** explains that the university normally never pays for that.
- Ernst asks whether a postponement might be sensible.
- Willi explains that it makes no difference whether we postpone or reject it, since in any case it would have to be resubmitted in the new term.

Dear all,

The Department of Internal Affairs has been approached by the heads of the two departments Gender Equality and Human Rights & Anti-Discrimination, as they would like to apply for a merger of their departments. The reason for the merger is the strong overlap in their subject areas. Both departments deal with anti-discrimination and supporting students in everyday university life. Therefore, it is not clear to either the Heads or the students where the substantive differences lie. Furthermore, both departments have long been understaffed and therefore less active than desirable. A merger could also help in this regard.

#### Discussion

- **Anne** asks whether it should be "Ansprechpunkt" (contact point) or "Ansprechpartner" (contact person).
- Willi asks whether perhaps "Anlaufstelle" (point of contact) would be better.
- "Ansprechpunkt" convinced the majority.

Dear all,

The Studierendenwerk Thüringen asked us last week whether we want to extend the currently dormant contract for the Thüringen semester ticket, which runs until SuSe 2026, from the WiSe 2026/27 with a maximum 6% price increase per semester. Why is this important? If the Germany-wide semester ticket is abolished, we would no longer have a ticket in Thuringia if we let the Thüringen semester ticket expire. Therefore, we consider an extension of this suspended contract very sensible. Especially since even the Studierendenwerk assumes that DB Regio would only extend the contract now.
